



TOUR OF SOUTHERN RHÔNE

12th - 19th May 2024

The Southern Rhône wine region spreads out from the river valley, red wines blended from multiple different grape varieties predominate, but also there are whites, rosés and sweet muscat in Beaumes-de-Venise; something for everyone! Guests will be based in Avignon, in a single hotel for the whole week, and all coach journeys are being planned to be less than 60 miles each way so that more time can be spent on activities rather than on travelling.

In 2019 the Club started its journey following the wine regions alongside the river Rhône; from its source in the Southern Swiss Alps, west through Lake Geneva where the river enters France, turning south in Lyon towards its Mediterranean outflow. The group visited the quality Swiss wine regions of Valais and Lavaux, before transferring to the

Northern Rhône wine region stretching along the valley between Vienne and Valence. You don't need to have been on the 2019 tour to join us in 2024, but those who were will see the contrast from the light white and red Swiss wines and the varietal syrah reds and marsanne and roussanne whites of the Northern Rhône.

This tour is planned to include visits with tastings to wineries in the major Southern Rhône sub-regions – Beaumes-de-Venise, Châteauneuf-du-Pape, Gigondas, Lirac, Rasteau, Tavel, Vacqueyras and Vinsobres – and to some named villages in the Côtes du Rhône, as always setting the visits into the local gastronomic, cultural, geographical, geological, historical & climatic context.

In addition to seven nights' bed and breakfast, there will be two included dinners and four included lunches. There will be a short guided walking tour of Avignon on arrival and one full day, mid-week, without any included activities so guests will be free to explore. Go to Avignon Tourisme (avignontourisme.com) for the massive range of options for your free time

International travel is not included, and can be by train, air or self-drive, with transfers from and back to Marseilles airport included at a time to be fixed when the airlines have published their schedules.

Prices in Western Europe have increased dramatically just as they have in Britain, and we need to reset our expectations. The tour is priced at £2,350 per person sharing (less than the inflation-adjusted price of the 2016 main tour), with a non-refundable and non-transferrable deposit of £500 per person.

Bookings are direct with Winetrails, not with the Club; the booking form and terms and BACS payment details are attached.

The tour starts with a wine tasting and dinner at the hotel on the first night and then there will be two days of winery visits, with included lunches, in the Setúbal area on the opposite side of the River Tagus. This area is particularly known for its Moscatel but, as we will discover, produces many other fine wines too. Many of the wineries have really interesting histories.


The tour finishes after breakfast on Sunday so you can choose to either leave then or make the most of being in such a vibrant capital city and stay on for a few hours or days.

The cost of the tour is £485 per person sharing, with a single person supplement of £155. There will also be a city tax of €2 per person per night.

Should you wish to extend your stay, the hotel has confirmed that you can do this at your own cost, on either side of the tour dates, at the group room rate of €140 for double occupancy and €130 for single. Please indicate on the booking form whether you wish to avail yourself of this as I will need to book it with the hotel.

WINETRAILS BOOKING CONDITIONS

All bookings are made and accepted subject to the terms and conditions that follow, and by signing the booking form you agree to this. The contract thus secured is between the signatory, acting on behalf of all members in his/her party, and Stephen Dallyn, trading as Winetrails, of Greenways, Yann Lake, Ockley, Dorking RH5 SNT; (hereinafter called 'us' or 'we').

To make a booking you must send us a signed booking form and the required deposit (normally 20% of your chosen travel arrangements, or other agreed sum). Your signature on the booking form indicates that you have read these booking conditions, essential information and other details referring to your holiday and understand and accept them. We will confirm your booking in writing and invoice you for the outstanding balance of your costs, at which time this contract oomes into force. The outstanding balance must be paid no less than ten weeks before the start of your chosen holiday, and should such payment fail to reach us by that date we reserve the right to cancel your booking without refund. Where a reservation is made within eight weeks of departure, that reservation is secured upon receipt of a completed booking form and the total holiday cost, including any extra payments that may be due. If you book through one of our authorised agents all monies paid to that agent for your holiday are held by them on our behalf.

If you cancel your booking, all payments made will be retained by us, at our discretion. If, however, you are unable to travel in circumstances we find reasonable and you notify us in writing not less than 56 days before departure, you may transfer your booking to another person (if they are acceptable to us), when a transfer fee of £100 per person will be payable (£200 if less than 56 days), plus any other irrecoverable costs. Additional costs levied on Winetrails, such as ariline fees, may also be payable by you under some circumstances. Such transfers are not generally possible less than 49 days before departure. Cancellations only come into effect on our receipt of written confirmation from the signatory. In view of the above, we strongly recommend you take out travel insurance cancellation cover at the time of booking.

If we are forced to cancel your holiday we will try to offer you a suitable alternative. If this is not acceptable, we will refund in full all monies paid to us in respect of tour cost and insurance. We will not be liable for any incidental costs, such as visa, vaccinations etc., nor for compensation payments.

This holiday is priced on exchange rates on 3rd July 2023 and for minimum numbers of people on group tours (in this case 20). Before your booking is confirmed by us we reserve the right to increase or decrease promoted prices. We also reserve the right to impose surcharges due to unfavourable exchange rate changes, air fare or other transport cost increases, government action, or where the group size falls below the minimum number. We will absorb all surcharges below

2% of the basic tour cost. If any surcharge exceeds 10% of the basic tour cost, you have a right to cancel your booking within seven days our notification of that surcharge; we will then retund any monies paid to us in respect of the tour and insurance, but not incidental expenses

Most of our holidays are constantly being developed and modified, to take in new routes, hotels or wineries, for example, or to allow for seasonal closures and other changes. Our brochures and newsletters include a detailed outline of each holiday and what it entails, but changes may occur after printing. After booking we may (if applicable) send you more up to date trip information on your chosen boliday, which is to be incorporated into the terms of the contract. If or receipt of this information you are not happy with the details of your boliday we will allow you to cancel, with a full refund, provided we receive written notification of such cancellation during the week following our sending this information to you. Such cancellations will in no case be allowed less than eight weeks of departure you should ensure you are fully familiar with all aspects of the proposed holiday.

Many of these are outdoor holidays of an adventurous nature, sometimes visiting remote areas, and on occasion may lead to inconvenience, discomitort and disappointment. Though we would not normally do so, we reserve the right to alter an itinerary and/or accommodation at any time, and will not be liable for any loss as a result of such alteration or delay. In particular, most of the wine estates we visit are as invited guests to working estates, not tourist centres, and as such conditions may changes or cancellations may occur at any time on any departure, but particular

schemes are specifically designed for these types of holiday, and we strongly recommend you to use them. All insurance claims must be directed to your insurers, and not to us, as we are unable to act in such matters

Any complaint should be made known at the earliest opportunity to the guide and/or our local representative, hotel or other supplier and every effort will then be made to rectify it. If you are not satisfied with their response, then you must notify us in Great Britain immediately, and we will do our best to resolve the situation. If at the end of the holiday you feel your complaint was not properly dealt with, the details should be put in writing to us within 14 days of the scheduled end of your holiday. Should the matter still not be resolved, you may take your dispute to independent arbitration.
